***** SECTION VI -- HEALTH HAZARD DATA *****

CARCINOGENICITY: Not listed by ACGIH, NTP or OSHA.

ROUTES OF ENTRY: Eye and skin contact.

EFFECTS OF OVEREXPOSURE: Eye Contact: No animal data are available. Evaluation of the individual chemical ingredients indicates that the mixture may have the potential to cause irritation to the eyes. Skin Contact: Limited to human experience indicates that the material may be mild irritant. An animal study, however, indicates that Sparkl is not irritating to rabbit skin. The acutely toxic dermal dose of Sparkl for rabbits is greater than 2.0 g/kg. No other long term toxicity information is available. Inhalation: None. Ingestion: None known.

EMERGENCY FIRST AID PROCEDURES:

Eye Contact: Flush eyes thoroughly with water for at least 15 minutes. Get medical attention. Skin Contact: Rinse thoroughly with water for at least 15 minutes; get medical attention if signs of irritation or redness develop. Inhalation: None anticipated under normal use. Ingestion: Give large quantities of water or milk; do not induce vomiting. Contact Poison Control Center and physician.

***** SECTION VII -- PRECAUTIONS FOR SAFE HANDLING AND USE *****

STEPS TO BE TAKEN IN CASE MATERIAL IS RELEASED OR SPILLED: Clean up spilled material using dry absorbent material; e.g., vermiculite. Handle entrained spill material as a hazardous waste. WASTE DISPOSAL METHOD: Dispose of in accordance with all Federal, State and Local regulations. PRECAUTIONS IN HANDLING AND STORING: This liquid is not for internal use. Keep away from extreme heat which causes hazardous substance formation.
